- Completed Application Form
- Official Tribal Documentation of enrollment in a Federal or State recognized tribe or Certification as an Indian artisan by an Indian Tribe/Nation.
- Description of art works on display & 2 or 3 pictures if possible (not required if a repeat vendor).
- Full-reduced Booth Fee (\$175.00) paid by December 31, 2017 made out to "Indigenous Institute of the Americas".
- **Applications received after December 31, 2017 the booth fee is \$225.00 that is due by March 5, 2018 in order to have a guaranteed booth.**

"Santa Fe Days IN THE PARK" is a scheduled event of the Indigenous Institute of the Americas, a 501(C) 3 nonprofit organization, conducted by the Santa Fe Days Organizing Committee.



Santa Fe Days is an outdoor event; artist booths will be under a permanent metal pavilion any overflow will be under a full large canopy. The park will open no earlier than 9 am for Vendor Set-up.



You will enter through the main gate, have \$2.00 cash for entry fee per person to keep traffic flowing. The park charges a \$2.00 admission fee per person, which you will be responsible for paying (cash only). Parking is Free!

We will provide \$4 dollars cash reimbursement to each booth for each day after set up at 10 a.m. for the park entry fee. Booths have easy access; you can drive up directly and unload. Parking is close-by.

Picnic tables with attached benches are available free. Please reserve your picnic table by March 5, 2017. If you would like to bring your own canopy to place under the pavilion or if you need folding tables and chairs, you will need to bring your own. In addition, the owners of the park live on site and entire area is fenced and locked at night for security. We recommend you have insurance for your equipment, as Santa Fe Days will not be responsible for any damage due to weather or any other circumstances. **THERE WILL BE A JUDGING FOR "BEST BOOTH PRESENTATION ". The First Place Winner Will RECEIVE \$400, 2nd Place \$300, 3rd Place \$200 & 4th \$100 cash!**
